SENATE CONCURRENT RESOLUTION—Directing the Legislative Commission to conduct an interim study concerning the laws of this State governing the protection of children.

1 WHEREAS, Current national standards encourage the provision  
2 of child and family services which focus on the preservation of the  
3 family while ensuring the safe protection of children; and

4 WHEREAS, Current child welfare practices include the  
5 implementation of a comprehensive and systematic method for  
6 family-centered support and intervention by agencies which provide  
7 child welfare services; and

8 WHEREAS, During the 2007-2008 interim, the Legislative  
9 Commission created a Subcommittee to Study the Placement of  
10 Children in Foster Care, which recommended a comprehensive  
11 review of the laws set forth in chapter 432B of NRS governing the  
12 protection of children in this State; and

13 WHEREAS, The laws governing the protection of children in this  
14 State were largely enacted in the 1980s and have not been  
15 systematically reviewed since being enacted; and

16 WHEREAS, The Nevada Legislature hereby recognizes the need  
17 for a review of the system for the protection of children to ensure  
18 that the system and relevant laws of this State are consistent with  
19 current child welfare practices, allow for the implementation of  
20 improvements to the system and standardize the criteria for the  
21 placement of children into foster care; now, therefore, be it

22 RESOLVED BY THE SENATE OF THE STATE OF NEVADA, THE  
23 ASSEMBLY CONCURRING, That the Legislative Commission is



1 hereby directed to appoint a committee composed of three members  
2 of the Senate and three members of the Assembly, one of whom  
3 must be appointed as Chair of the committee, to conduct an interim  
4 study of the system and laws governing the protection of children in  
5 this State; and be it further

6 RESOLVED, That the committee should solicit the input and  
7 recommendations of persons and entities concerned with the system  
8 of child welfare, including, without limitation, children and families  
9 who are provided services by child welfare agencies and any  
10 agencies and organizations which provide child welfare and related  
11 services in this State; and be it further

12 RESOLVED, That the committee shall recommend such action as  
13 may be necessary to provide:

14 1. Clear standards for the protection of children in this State,  
15 including, without limitation, reviewing the definition of "abuse or  
16 neglect of a child" to ensure it conforms with such standards; and

17 2. For the effective and efficient implementation of strategies  
18 to preserve and build safe families; and be it further

19 RESOLVED, That any recommended legislation proposed by the  
20 committee must be approved by a majority of the members of the  
21 Senate and a majority of the members of the Assembly appointed to  
22 the committee; and be it further

23 RESOLVED, That the Legislative Commission shall submit a  
24 report of the results of the study and any recommendations for  
25 legislation to the 77th Session of the Nevada Legislature.
