Presentation

Amy Ayoub gave a presentation on the activities of the Federal Commission to Eliminate Child Abuse & Neglect Fatalities (CECANF). This commission is nationally funded for 2 years with a possible 1 year extension. They are conducting broad discussions and collecting data in an effort to identify solutions and report back to the President and Congress. The commission is

comprised of 12 national members. A discussion ensued regarding the funding and effectiveness of Title 4 as well as of local, state and federal programs that address Child Abuse and Neglect Fatalities, and the inconsistencies of data collection. Participants offered areas of concern that hold a possibility for developing programs and solutions to address the mission of this commission.

The Commission to Eliminate Child Abuse and Neglect Fatalities (CECANF), a federal advisory committee established by the Protect Our Kids Act of 2012 (P. L. 112-275), will hold open meetings in Denver, Colorado, on September 22 and 23:

- **Testimony and stakeholder presentations:** Monday, September 22, 2014, from 8:00 a.m.–5:00 p.m. MDT (Public may attend in person or via webinar and teleconference.)
- **Commissioner deliberations:** Tuesday, September 23, 2014, from 8:30 a.m.–2:30 p.m. MDT. (Public may attend via teleconference, **no webinar available.**)

Location: One Denver Federal Center, Building 41—Remington Arms Room, Denver, CO 80225.

Attendance: Individuals interested in attending the meeting in person or via webinar and teleconference must register in advance (see link below). Meeting agenda: CECANF was established to develop a national strategy and recommendations for reducing fatalities resulting from child abuse and neglect. The purpose of this meeting is for Commission members to gather national and state-specific information to better understand the extent of, and risks associated with, child abuse and neglect fatalities. The Commission will hear from researchers and experts from such disciplines as child welfare, law enforcement, health, and public health regarding:

- The scope of the problem
- Strategies for improving national data collection
- Policy barriers and opportunities to reduce maltreatment fatalities
- Confidentiality issues

- Potential solutions

Preparing for the 2015 Legislative Session

Denise gave the Legislative update for CAA and provided a document summary of bill and bill draft requests for the 2015 Legislative Session. She stated that the 432B Work Group was not continued. Three areas of focus will be addressed during this session;

Children’s Safety

School Readiness

Children’s Health

She also shared that a White Paper is being developed to explore and define “Prudent Parent Legislation” to allow normalcy for foster youth in Nevada. CAA is also looking into medical consent issues to identify more effective solutions to ensure that children in foster care receive timely and adequate medical treatment.

Funding/Grant Opportunities

The discussion on Grant Opportunities resulted in a consensus that the sources for identifying Grant opportunities is limited and by the time opportunities are posted it is difficult to meet deadlines in a collaborative way.

Daniele Dreitzer mentioned that there is some funding available from the State Farm Youth Advisory Fund. She had determined that there is no one from Nevada that sits on the Board of this funding agency which is comprised of 16-24 year olds.

Gard Jameson announced that there are some efforts being made to develop a source that "Previews Non-Profit Organizations in Nevada". He also referenced a recent report from the Lincy Institute on the economic impact of non-profits in Nevada. This report can be accessed at: [click here](#)
